Report of the Board Chair and Executive Director

This year has gone by in a flash, and there have been a lot of exciting things happening! We're filled with gratitude as we reflect on the past year and extend heartfelt thanks to our dedicated staff, supportive funders, valued partners, and the community we serve.

We have remained dedicated to providing high-quality primary care services, even as we continue to navigate staff vacancies and sector-wide pay disparities. In collaboration with our primary care team, we have taken steps to improve workload management, including the implementation of an AI scribe tool and the introduction of an online booking platform to enhance service accessibility and efficiency. We remain committed to delivering essential allied health services and community-based programs that support the wellbeing of our community.

We are thrilled to share that we have completed our capital project and have officially moved into our new home! This milestone would not have been possible without the unwavering support and funding from the Ministry of Health Capital Branch, the exceptional vision and design of Unity Designs (formerly Lett Architects), and dedication and craftsmanship of J.J. McGuire General Contractors. A special thank you to our generous capital donors – your belief in our mission helped this dream become a reality. We are truly grateful to be home at last.

We have continued to invest in strong, collaborative partnerships grounded in meaningful relationship-building. Our work with the North Durham Family Health Team has enabled the delivery of a much-needed clinic for "unattached" individuals – those without a primary care provider – within both our former and new facilities. We are also pleased to welcome Dynacare lab services into our new Cannington home, enhancing access to essential diagnostics for our community. In addition, we continue to strengthen partnerships with organizations such as Ontario Shores and their Ontario Structured Psychotherapy program, VON, The Nourish and Develop Foundation, Alzheimer Society Durham Region, the Region of Durham's Oral Health Program, and Community Care Durham, among others. Our focus remains clear: to bring services closer to our rural community, improving equity and access for all.

We are deeply grateful that the Ministry of Health is moving forward with its Primary Care Action Plan – an historic \$1.8 billion investment aimed at connecting two million people to primary care over the next four years. This bold initiative marks an exciting new chapter for healthcare in Ontario. Under the leadership of Dr. Jane Philpott, the Primary Care Action Team will collaborate with the sector to implement initiatives that connect people to primary care providers, make healthcare more integrated and convenient, and provide essential support to those delivering care. Community Health Centres (CHCs) like ours are well-positioned to play a vital role in this transformation. The CHC model is uniquely equipped to deliver care that is equitable, accessible, inclusive, and accountable – offered within a community-based, locally governed framework. At Brock CHC, we are ready and eager to be part of this evolving primary care system. We are committed to advocating for the needs of our rural community in Brock Township, ensuring that no one is left behind in this progress.

We are able to embrace this moment of change because we are supported by a strong, community-minded Board of Directors; a team of compassionate, skilled, and dedicated staff; trusted partners who share our values and vision; and a government that is investing in the kind of healthcare we provide.

We are grateful to be here – now – where real, meaningful change is happening.

2024-25 Highlights

Advancing Technology

- Brock CHC participated in an AI pilot project with OntarioMD. All Primary Care practitioners are now
 using Tali AI Scribe Program to assist with documentation of client visits which reduces their
 workload.
- Funding from Ontario Health provided two licences for on-line appointment booking. These are being used by our RPNs to schedule lab services.

Advocacy

- Ongoing advocacy efforts were taken to support the community health sector in Ontario by
 participating in the "Closing the Gap/For Us For You" campaign. This province-wide campaign was in
 response to the market survey regarding salaries within CHCs and how the wage disparity is
 impacting recruitment and retention of staff.
- Brock CHC also continues to advocate for additional funding to increase our primary health care services for all of Brock Township and to promote equitable funding for rural areas.

Increasing Services through Collaboration

- In collaboration with North Durham Family Health Team (NDFHT), an "Unattached Patient Program" is now operating in Brock CHC's facility one day a week, providing primary care services to those who currently do not have a provider.
- Discussions between Brock CHC and DynaCare have resulted in Dynacare occupying space in our new building to provide lab services for the community (beginning June 16, 2025).

Community Outreach

- Brock CHC welcomed the opening of Beaverton Heights Supportive Housing. Our Community
 Development team has referred a number of clients and continues to work closely with the service
 operators (Blue Door).
- 257 flu shots were given by our RPNs to seniors in Brock's community housing residences as part of our outreach program.
- In partnership with Community Care Durham, 250 Holiday Meals for Seniors were purchased and distributed to seniors living in Brock's community housing residents.

Brock CHC and North Durham Family Health Team Partnership

North Durham Family Health Team, in collaboration with Brock CHC, has been providing primary care services at our Cannington site once a week to members of the north Durham community who do not currently have a primary care provider. This is a valuable resource for those who need immediate care but lack a doctor or nurse practitioner. Since October 2024, 64 (unique) patients were seen at the Brock CHC Unattached Patient Clinic. 149 interactions with the Nurse Practitioner were completed during that same period. The clinic runs on Thursdays and can be accessed by calling 905.985.2895 ext. 6070.
